

# How to complete a transfer form.



## AUSTRALIAN SHOW RABBIT COUNCIL INC. NATIONAL RING TRANSFER FORM

Any rabbit acquired by direct sale, lease or gift must have its ring number transferred by the ASRC before it can be exhibited in the name of the new owner(s) or in the case of a doe, a litter hold their stud name. Transfer forms can be downloaded from the ASRC Website or requested from the Secretary. Transfer forms to be made available from the current registered owner who will complete Part 1. The transfer request to be sent by the purchaser to the ASRC, PO Box 2061 Elizabeth Park SA 5113, entered online or lodged with your local affiliated Club. Part 2. Multiple ring transfers can only be accepted if all the rabbits are bought at the same time, from the same registered owner and transferred to the same new registered owner(s) or stud.

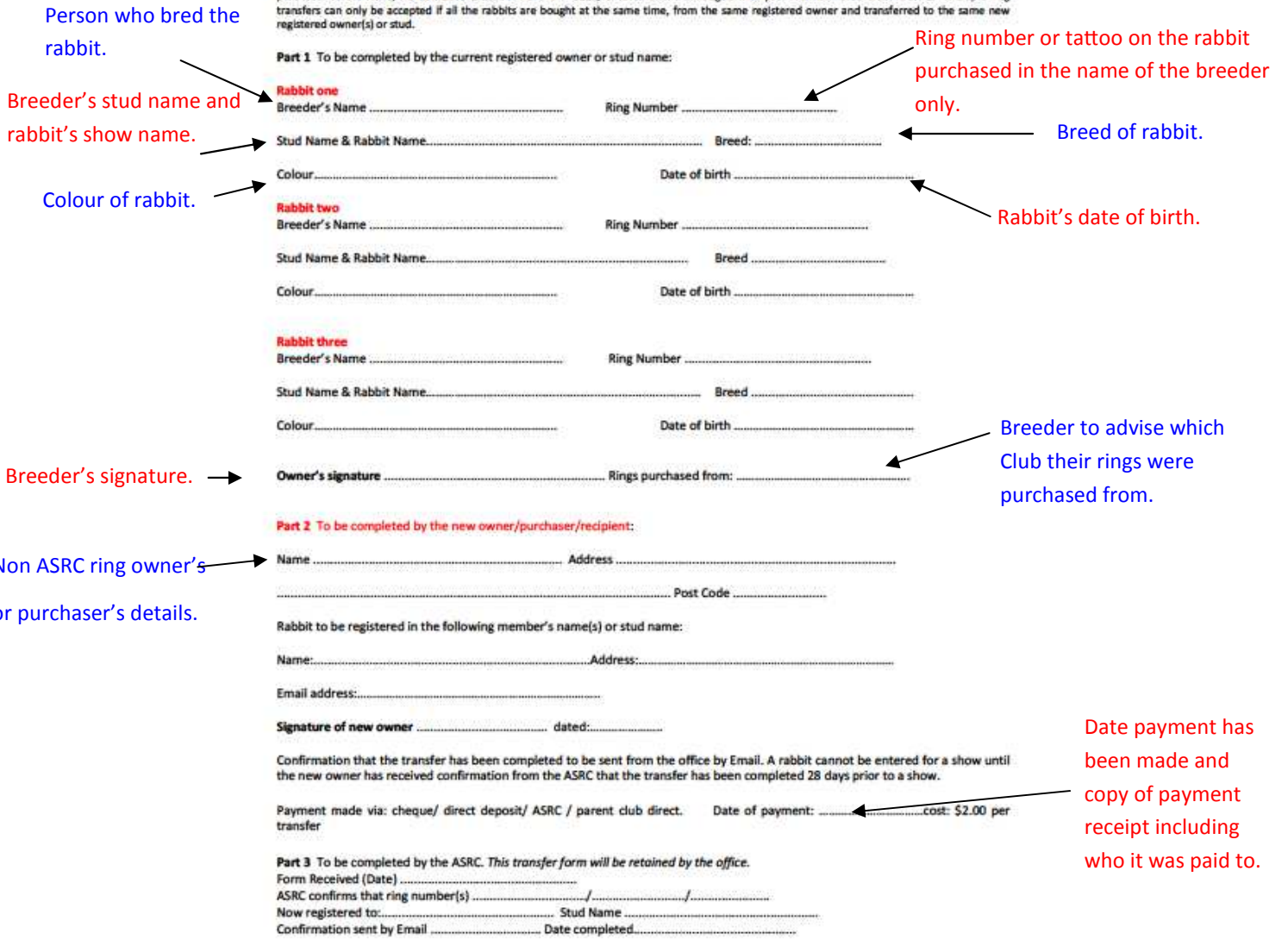

Once a rabbit has been entered and the form dated please do not add rabbits on the form with different transfer or purchase dates. Please use a new form for each date of lodgement. One lodgement per form only will be accepted. Additions or alterations will effect the date received and potentially your rabbit's transfer may be held up.

ASRC and BRC rules currently require a transfer to be completed 28 days prior to exhibiting by the new owner. This is to ensure a satisfactory time frame for a new rabbit to be quarantined and ensure it is disease free.
